- All anglers must be off the lake no later than 2:00 on 24 October 2024. Registration and Pre-Tournament meeting will be at the pavilions/picnic area located by the fish cleaning station inside the park on 24 October 2024, check-in, late sign-ups and payment into option pots starts at 3:00, raffle starts at 3:30 and the pre-tournament meeting and first days partner pairing starts at 4:00 p.m.
- To be eligible for the 2025 Utah B.A.S.S. Nation State Team you must be a current member of the following: The B.A.S.S. Nation and the Utah B.A.S.S. Nation, you also need to have an active subscription to BASSMASTER magazine prior to the start of the tournament. This event is a random draw tournament. Guests may fish this event if there are open spots at an additional cost of \$15.
